The new cohort who entered Nursery at January 2013 are now included in the totals.

Implications for school organisiation from these pupil numbers

It is likely, but not certain, that the school would become a seven class school with a nursery/pre-school in August 2013. Following discussions with staff and the Education Dept the most sustainable model would be to open two parallel, composite Primary 1/2 classes. The rest of the school would be organised in single cohort classes. So we would have – P1/2; P1/P2; P3; P4; P5; P6; P7.

If we do not receive an additional class teacher the school could be composited: P1/2/3; P1/2/3; P3/4; P4/5; P5/6; P7. It is hoped that this could be avoided, but it does depend on the school being given an additional class teacher.

Stage 1 is the lowest stage of intervention and Stage 5 the highest. Stage 3 involves outside agencies.

Staffing

Kerry Flett has been appointed as a part-time auxiliary. Kerry is now in post. Charis Hourston has been appointed as the additional early years worker for nursery and pre-school. Charis will begin work on 18th February. We welcome both Kerry and Charis to the staff of the school.

Headteacher activity

Currently I am working on:

- School Improvement Plan
- Anti-bullying policy
- Staff continuing professional development
- Development of the learning and teaching of reading
- Use of technology in school and the technology curriculum
- Children's play
- Further development of support for learning

I am supporting the learning of reading in two classes; I teach one session a week in P1 and I teach one session with P7 each week, developing the Primary 7 profiles. Recently I have been covering absence more than usual as we are having difficulty obtaining supply cover for teachers.

I have attended departmental headteacher meetings. I have attended my annual staffing meeting with Education, Leisure and Housing Services.

The school is hosting an in-service training session for teachers across the authority on the morning of 7th February. Teachers from Dounby will lead a number of the sections of the training on that day.

I have been invited, with a member of the department staff, to speak at a meeting hosted by CEM and Highland and Islands Council in Stirling on 26th February.

Roots & Shoots

We published a Fair Trade cookbook for the Christmas Fayre.

I have been establishing links with a school in Malawi with the aim of the children exchanging information and we as a school supporting them with resources occasionally. This link came about through a Fair Trade representative, Kester Chiwalo who manages a fair trade tea estate in Malawi. Kester visited school last year.

School Council

I have re-established a traditional school council and this is now meeting weekly.

Standards and Quality Report

The Standards and Quality report has been agreed and is now published.

Anti-bullying policy

Surveys of the staff and of the parents have been completed. In particular Nicola Moar's leadership should be recognised, as well as the very good work of Phyllis Ballantyne, Helen Johnstone, Hazel McKinlay, Rachel Garson, Charis Hourston and all the other staff who have played a part in the further development of our nursery and pre-school.

<u>ICT</u>

The school is in the process of self-evaluating the the learning and teaching of ICT skills and knowledge. From this should come a new programme of learning for ICT across the school.
