The new cohort who entered Nursery at April 2013 are now included in the totals.

#### Implications for school organisation from these pupil numbers

It is likely, but not certain, that the school would become a seven class school with a nursery/pre-school in August 2013. With the discretionary deferrals added to a child leaving and the automatic deferrals the school could then organise with single age cohort classes.

If the school does not receive an additional teacher, it would be possible to organise the school P1, P2, P3 and with three composite classes P4/5, P5/6 and P6/7. These three composite classes would each be at the maximum size of 25, so if a child arrived in those age groups a teacher would have to be appointed and the school reorganised. It is likely that there will be two composite Primary 1/2 classes because of the numbers entering Primary 1 this year (P1 is legally limited to 25 children).

Stage 1 is the lowest stage of intervention and Stage 5 the highest. Stage 3 involves outside agencies.

### **Staffing**

Charis Hourston began work with us as an additional early years worker in our nursery on 18th February.

### Headteacher activity

Currently I am working on:

- School Improvement Plan
- Monitoring of planning and assessment
- Monitoring via pupil's view pastoral care and learning
- Assessment
- Staff continuing professional development
- Development of the learning and teaching of reading
- Use of technology in school and the technology curriculum
- Children's play
- Monitoring of the teaching and safety of swimming arrangements

I am supporting the learning of reading in P5/6; I teach one session a week in P1 and I teach one session with P7 each week, developing the Primary 7 profiles. Recently I have been covering absence more than usual as we are having difficulty obtaining supply cover for teachers. I am supporting excursions for a number of classes.

I attended and spoke at a meeting hosted by CEM and Highland and Islands Council in Stirling on 26th February.

I attended the Chaplains' Conference and the Headteachers' Conference, both OIC organised events in Kirkwall. I attended the probationary teachers' "Peedie Projects" presentation afternoon in Kirkwall.

## Roots & Shoots

The school is planning to have an environmental theme running through its work in the next two years. This will encourage teachers to ensure that children understand the environmental issues that affect them, for example, global warming and pollution.

## School Council

School Council held a coffee morning at the end of last term to raise money for a school in Malawi. The coffee morning raised £88.38. The School Council will repeat this event but for another cause later this term.

## School Improvement Plan

The new plan will take in the following areas. The plan is not completed at this time as I am awaiting confirmation of the local authority priorities. The school's priorities are:

- Talking and listening.
- Maths especially the teaching of maths in the early years and First Level.
- Science developing teacher's knowledge of scientific method and how that is taught.
- Health and well-being including children's play.
- ICT pupil safety and learning about how to use ICT safely and appropriately.

The plan needs to include the local authority priorities and national initiatives.

### Anti-bullying policy

The policy has been presented to the Parent Group previously and following some minor adjustments and the completion of the pupil survey it now requires formal approval.

### Nursery inspection

The final report was published in March and is attached with the other papers for this meeting.
